ALBANY PARK ROAD

CONSERVATION AREA

EARLY this year proposals were submitted to Kingston Development Committee for the creation of a new Conservation Area based on the 55 residential properties nos. 2 to 36 Albany Park Road and nos. 179-to 213 and 194 to 234 Richmond Road, Kingston.

The Kingston Society then proposed to the Council that the conservation area should be enlarged to include properties, some of which were of a later period and smaller and more cheaply built, in St Alban's Rd, Latchmere Rd and Studland Rd. Details of these



proposals were put up on the notice boards of our three Courts.

Following further consultations with owners and amenity organisations the enlarged area has been designated for conservation. A relief, perhaps, that here at least the bulldozers should be kept at bay!

## ALBANY BOATHOUSE

WE LEARN that Creed Miles have recently withdrawn a one-year old application to have their business re-registered as Class Bl, which was said to be merely a "regularising" procedure. There is a strong feeling among local residents that such a business shouldn't be there at all. Protests continue about their riverfront car parking and heavy goods vehicles impeding local traffic. It all seems especially incongruous, adjoining the new Conservation Area.

Moreover, the stretch of riverside land is identified in Kingston's development plan as a Strategic Area of Special Character; its use, according to the Plan, should be restricted to public open space, water-related recreational use, other leisure use, and residential or hotel.

Originally, of course, the business in the Albany Boathouse had to do with boats.

FIRE! At present we have portable fire-extinguishers standing on alternate landings of the three Courts. The Committee feel it would be an improvement to have them on all floors so that nobody need run up or down steps looking for one in an emergency. The extra appliances are on order, and should turn up soon. [Ceiling smoke detectors, as recommended by the Fire Service, are best installed inside flats.]

FACELIFTS? Every now and then we get complaints that the lifts are getting shabby, let the place down, need "refurbishing". On the other hand quite a strong body of opinion feels there's nothing wrong with them and we shouldn't spend money on them. So we've been having a look at what the costs might be...

A full-scale refurbishment, including Formica linings, would cost thousands, which we feel is out of the question. At the other end of the scale we could consider a modest rear-wall mirror with a protective buffer rail, and perhaps some concealed strip lighting in the ceiling. So far, quotations even for this have been unacceptably high. If we find anything reasonable, we'll put it to residents for their views.

INTERIOR REDECORATION seems to be going along well, and the two Courts where the work is completed show a great improvement. Under the terms of the Lease this work couldn't be put off any longer.

CARPORTS. We are still pestered regularly by trespassers breaking into cars and pinching such things as engine or bodywork parts, or radio sets, or parking money. Petrol may get syphoned off, and wheels have been known to disappear. Over the years many proposals have been investigated for making the carport area secure, with various alarm systems - but all too costly and none, one should imagine, 100% vandal-proof. The only reasonable measure is for individual car owners to equip their vehicles with good anti-theft devices.

THE HOSE REEL at the car wash stand got very tatty and came to the end of its natural life. Now we have a nice new one.

**NEW STRIP LIGHTING** has recently been installed in the Lift motor rooms, and also in the rooftop water tank rooms.

### SWIMMING

WE WERE ABLE to start the swimming season earlier this year, which was fun. Yes, it would be nice if the pool were larger - but really, we're lucky to have one at all. Perhaps this is the moment to remind all residents, and to invite new ones, to look at page 6 of the Association Housebook. It explains the agreed conditions for Swimming Pool use which we should all take care to observe.

If you should see, or hear, trespassers round the Pool in the night - possibly chucking garden furniture into the water - please dial 999 and tell the Police immediately... all part of our Neighbourhood Watch requirement.



THE REPAIRED and repainted fountain looks rather nice, doesn't it?

SORRY about the area of broken paving behind the pumphouse still needing attention. It was excavated last year to see if there was any serious cause of the constant subsidence of paving round the building.

Since then, experts have analysed soil and drainage samples, and probed with TV camera to see what's going on down below, before we go to the expense of having the subsided area repaved again. It seems

there's nothing more dire than normal old age. So the restoration work will start soon.

REMEMBER our lime tree (subject to a Tree Preservation Order) which was decapitated by the 1987 hurricane? It's to be replaced, by agreement with Kingston Planning office, by a gladitzia. This, we are assured, is a slowish-growing tree which is even more splendid than its name. Frank Armstrong, our Gardens Committee chairman, will be able to tell you what it looks like. We're very pleased to learn that it doesn't attract the clouds of greenfly that used to make the evening lime tree look as if it was smoking. Unfortunately the gladitzia won't be available for planting until the autumn. In the meantime the hole in the ground is filled, temporarily, with a lavatera, the up-market name for a mallow which may grow up to 5 ft and is supposed to flower all July to September.

### SATELLITE T.V.

WE ARE KEEPING an eye on the satellite TV situation and are awaiting information from Kingston Planning Office about current or projected regulations controlling antennae ("dishes") for blocks of flats. As more TV channels come into service, so it seems more and more dishes will be required. The mind boggles at what the buildings and skylines may look like eventually.

The alternative is cable TV. It would be an expensive business bringing cables to the three courts. But once that was done, individual receivers in the flats could be plugged into the system on the same basis as that for our existing communal TV aerials. It's all rather complicated, and would cost thousands.

The whole business is in its infancy, but we're monitoring the general situation and keeping in touch with our TV aerial suppliers. At some future date we may arrange a general meeting for one of their experts to come and explain the options - and costs!

<u>Meanwhile</u>, a reminder...Our leases forbid us to fix anything to the outside walls of our flats. Individual external dishes are strictly TABU.

### A MESSAGE FROM THE SECRETARY

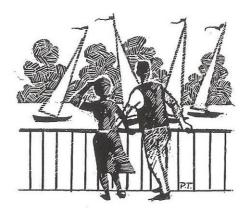
